# HUNTINGTON DRIVE AND SECOND AVENUE INTERSECTION BRIDGE CONSTRUCTION

### **WHAT**

Work will commence on the bridge structure over the intersection of Huntington Dr and Second Ave in the City of Arcadia, as part of the 11.5-mile Metro Gold Line Foothill Extension light rail project. The current bridge structure will be widened to accommodate two new light rail tracks. This bridge construction will begin in December 2013 and is anticipated to be completed in May 2014.

## **WHEN**

- <u>During the months of December 2013 April 2014</u>: Crews will be working on the bridge columns on the northwest and southeast corners of the intersection. No long-term detours will be needed as part of this work; however, northbound Second Ave at Huntington Dr will be narrowed to one lane.
- <u>Wall Construction along Indiana St, December 2013 January 2014:</u> A new retaining wall will be built along
  Indiana St (located between First Ave and Second Ave, east of where Wheeler Ave dead-ends), adjacent to the
  railroad corridor. During the wall construction, parking will not be available along Indiana St. Additional parking is
  available at public parking lots located on Wheeler Ave between Santa Anita Ave and First Ave and between First
  Ave and Indiana St.
- Additional lane closures will be implemented as needed and construction notices will be distributed prior to work taking place.
- Standard construction work hours are 7:00 a.m. to 6:00 p.m., Monday through Friday.

## **TRAFFIC ADVISORIES**

- Northbound Second Ave at Huntington Dr will be narrowed to one lane of traffic; however, motorists will be able to continue northbound on Second Ave, turn left onto westbound Huntington Dr and right onto eastbound Huntington Dr (see map).
- Portions of the sidewalks at the intersection will remain accessible to pedestrians during construction. A temporary pedestrian detour will be implemented at the portion of the sidewalk that is closed; signage will be posted to direct pedestrians.
