Metro Gold Line Foothill Extension
- Pasadena to Azusa -

NIGHTLY DIRECTIONAL CLOSURES OF SANTA ANITA AVENUE

WHAT

Crews will remove the wooden forms from the newly constructed Santa Anita Ave bridge structure, as part of the 11.5-mile Metro Gold Line Foothill Extension light rail project. **For the safety of motorists, pedestrians and workers during the removal of the forms, traffic will be detoured around the work area. This activity requires full directional (one-way) closures of Santa Anita Ave (between Colorado Blvd and Santa Clara St) during the nighttime and early mornings for two nights in each direction.**

WHEN

- Monday, April 28, 2014 and Tuesday, April 29, 2014, 9:00 p.m. to 6:00 a.m. only*: Northbound Santa Anita Ave will be closed to thru-traffic between Colorado Blvd and Santa Clara St.
 - Wednesday, April 30, 2014 and Thursday, May 1, 2014, 9:00 p.m. to 6:00 a.m. only*: Southbound Santa Anita Ave will be closed to thru-traffic between Colorado Blvd and Santa Clara St..
- NOTE: Construction schedules are subject to change*.*

TRAFFIC ADVISORIES

- Santa Anita Ave will be closed to thru-traffic including motorists and pedestrians between Colorado Blvd and Santa Clara St during the nighttime / early morning work hours shown above. Traffic will be detoured and signage will be posted to direct motorists and pedestrians during these closures. In addition, some turn lanes will be restricted.
- La Porte St and St. Joseph St will each be closed to thru-traffic at Santa Anita Ave.
- Bus stops in this vicinity may be temporarily relocated. For information about:
