NIGHTTIME CLOSURES OF SECOND AVENUE AT HUNTINGTON DRIVE

WHAT

As crews continue to work at the bridge structure over the intersection of Huntington Drive and Second Avenue in the City of Arcadia, installation of new traffic signals and additional preparatory work under the existing bridge structure will be performed. In order to complete this work, crews will implement nighttime closures of Second Avenue south of the intersection with Huntington Drive, as well as directional (one-way) closures of Huntington Drive at Second Avenue. This work is being performed as part of the 11.5-mile Metro Gold Line Foothill Extension light rail project.

WHEN

Work is scheduled to begin on Sunday, July 20, 2014 and continue until August 1, 2014. Anticipated work hours are 8:00 p.m. to 6:00 a.m., Sunday – Thursday only. No work will take place on Fridays or Saturdays.

- Sunday, July 20, Monday, July 21, Sunday, July 27, and Monday, July 28 (8:00 p.m. to 6:00 a.m. only): Second Avenue will be fully closed to thru-traffic south of the intersection with Huntington Drive. Thru-traffic on Huntington Drive will remain open with at least one lane of traffic open in eastbound and westbound directions. Various turn lanes will be restricted at the intersection of Second Avenue and Huntington Drive.
- Tuesday, July 29 – Thursday, July 31 (8:00 p.m. to 6:00 a.m. only): Second Avenue will be closed to thru-traffic in both northbound and southbound directions at the intersection of Huntington Drive. Thru-traffic on Huntington Drive will remain open in eastbound direction. Westbound traffic on Huntington Drive will be closed at the intersection with Second Avenue and motorists will be directed to turn north onto Second Avenue. Various turn lanes will be restricted at the intersection of Second Avenue and Huntington Drive.

Additional lane closures will be implemented in the months of August - October 2014 to set the new bridge girders and deck beams; additional notifications will be provided prior to work taking place.

TRAFFIC ADVISORIES

- Second Avenue will be closed to thru-traffic and some turn lanes will be restricted at the intersection with Huntington Drive. During the closures, traffic will be detoured and signage will be posted to direct motorists.
- Portions of the sidewalks at the intersection will remain accessible to pedestrians during construction. A temporary pedestrian detour will be implemented and signage will be posted to direct pedestrians at the portion of the sidewalk that is closed.

- Construction equipment noise will be produced near the work zones.
