NIGHTTIME CLOSURES OF MYRTLE AVE AND POMONA AVENUE TO INSTALL UNDERGROUND CONDUITS

WHAT

Crews will install new traffic signals at the intersection of Myrtle Avenue and Pomona Avenue in the City of Monrovia. During this work, Myrtle Ave and Pomona Ave will each be closed to thru-traffic for one-night at a time to install underground conduit in preparation for the traffic signal installation. Once these two closures are completed, work will continue in the area to install new traffic signals and this intersection will become a fourway signalized stop. This work is being performed as part of the 11.5-mile Metro Gold Line Foothill Extension light rail project.

WHEN

Work is scheduled to take place over two nights as described below:

- Thursday, July 24, 2014 from 8:00 p.m. until 6:00 a.m. the following morning: Myrtle Avenue will be closed to thru-traffic in both northbound and southbound directions at the intersection with Pomona Ave. Thru-traffic on Pomona Ave will remain open with at least one lane of traffic open in eastbound and westbound directions.
- Friday, July 25, 2014 from 8:00 p.m. until 6:00 a.m. the following morning: Pomona Avenue will be closed to thru-traffic in both eastbound and westbound directions at the intersection with Myrtle Avenue. Thru-traffic on Myrtle Avenue will remain open with at least one lane of traffic open in northbound and southbound directions.

TRAFFIC ADVISORIES

- During the closures, detour routes will be in place and signage will be posted to direct motorists.
- Following these closures, work will continue at the intersection with at least one lane of thru-traffic open in each direction.
- Note: Magnolia Ave is anticipated to re-open to thru-traffic on Friday, July 18, 2014
- Bus stops in this vicinity may be temporarily relocated. For information about:
