Metro Gold Line Foothill Extension
- Pasadena to Azusa -



Four-day Intersection Closure of Huntington Drive / Second Ave Intersection

Friday, August 8, 2014 (12:00 am) thru Tuesday, August 12, 2014 (6:00 am)

Followed by Six-weeks of Nighttime Directional Closures

WHAT

As crews continue to work at the bridge structure over the intersection of Huntington Dr and Second Ave in the City of Arcadia, installation of the new steel bridge girder will be performed. A four-day (around the clock) full intersection closure of Huntington Dr and Second Ave is needed to perform this work. Following the installation of the bridge girder, a set of directional (one-way) nighttime closures of Huntington Dr (which also includes no thru-traffic on Second Ave) will begin for approximately six weeks to install the cross beams and deck steel. This work is part of the 11.5-mile Metro Gold Line Foothill Extension light rail project.

WHEN

- Friday morning, August 8, 2014 at 12:00 am until Tuesday, August 12, 2014 at 6:00 am*: The intersection of Huntington Dr and Second Ave will be fully closed to thru-traffic to install the bridge girder. Traffic will be detoured and signage will be posted to direct motorists and pedestrians.
- August 12, 2014 for approximately six weeks, Sundays thru Thursdays only, 8:00 pm to 6:00 am: Huntington Dr will be closed to thru-traffic at Second Ave in either eastbound or westbound direction (not concurrently) and thru-traffic on Second Ave at the intersection will be restricted to install the cross beams and deck steel. Traffic will be detoured and signage will be posted to direct motorists and pedestrians during these hours. No work will be performed on Fridays or Saturdays.

TRAFFIC ADVISORIES

- The intersection of Huntington Dr and Second Ave will be fully closed to thru-traffic for four consecutive days (24 hours/day). Detour routes will be in place during the intersection closure and signage will be posted to direct motorists and pedestrians (see map).
- Following the four-day full intersection closure, the directional (one-way) nighttime closures of Huntington Dr will begin and include no thru-traffic on Second Ave and detour routes will be implemented with signage posted to direct motorists and pedestrians.
- Bus stops in this vicinity may be temporarily relocated. For information about Foothill Transit bus stops, call (800) RIDE-INFO, (800-743-3463).

NOTES TO LOCAL RESIDENTS / BUSINESSES

- Construction equipment noise will be produced near the work zones.
- **Access to all local businesses including those on Huntington Dr and Second Ave will remain available. We encourage support of local businesses during construction.**

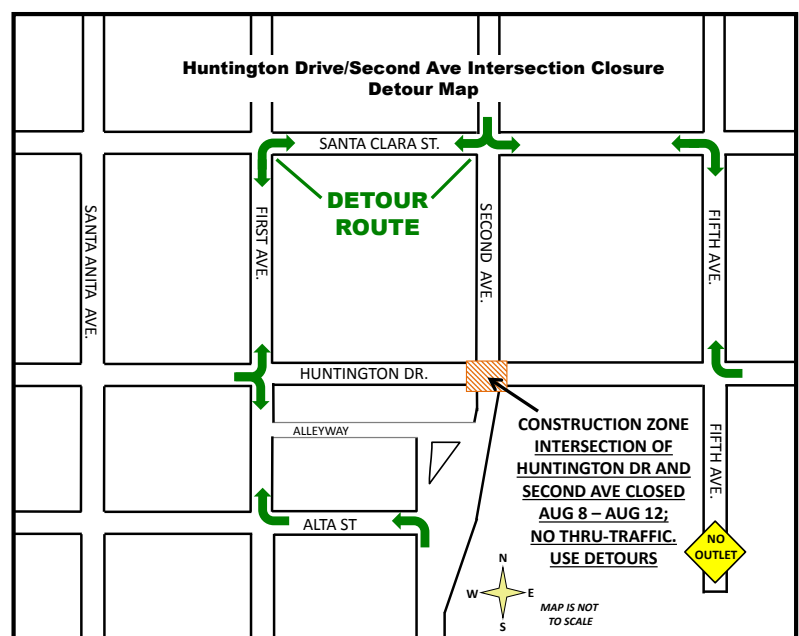
