One-night Intersection Closure of Huntington Drive / Second Ave

Tuesday, September 16, 2014 (8:00 pm) thru Wednesday, September 17, 2014 (6:00 am)

WHAT

Crews will perform a concrete pour on the newly constructed bridge structure over the intersection of Huntington Dr and Second Ave in the City of Arcadia. A one-night full intersection closure of Huntington Dr and Second Ave is needed to perform this work. Following the concrete pour, crews will begin to paint the bridge which requires a set of directional (one-way) nighttime closures of Huntington Dr (which also includes no thru-traffic on Second Ave) for approximately three weeks. This work is being performed as part of the 11.5-mile Foothill Gold Line light rail project.

WHEN

- Tuesday, September 16, 2014 from 8:00 pm until Wednesday, September 17, 2014 at 6:00 am*: The intersection of Huntington Dr and Second Ave will be fully closed to thru-traffic to pour concrete atop the bridge deck.
- Starting September 21, 2014 for approximately three weeks, Sundays thru Thursdays only, 8:00 pm to 6:00 am: Huntington Dr will be closed to thru-traffic at Second Ave in either eastbound or westbound direction (not concurrently) and thru-traffic on Second Ave at the intersection will be restricted to paint the bridge girders. No work will be performed on Friday or Saturday nights.

TRAFFIC ADVISORIES

- The intersection of Huntington Dr and Second Ave will be fully closed to thru-traffic for one night. Detour routes will be in place during the intersection closure and signage will be posted to direct motorists and pedestrians (see map).
- Directional (one-way) nighttime closures of Huntington Dr will begin thereafter and include no thru-traffic on Second Ave and detour routes will be implemented with signage posted to direct motorists and pedestrians.
- Bus stops in this vicinity may be temporarily relocated. For information about Foothill Transit bus stops, call (800) RIDE-INFO, (800-743-3463).

NOTES TO LOCAL RESIDENTS / BUSINESSES

- Construction equipment noise will be produced near the work zones.
- **Access to all local businesses including those on Huntington Dr and Second Ave will remain available. We encourage support of local businesses during construction.**

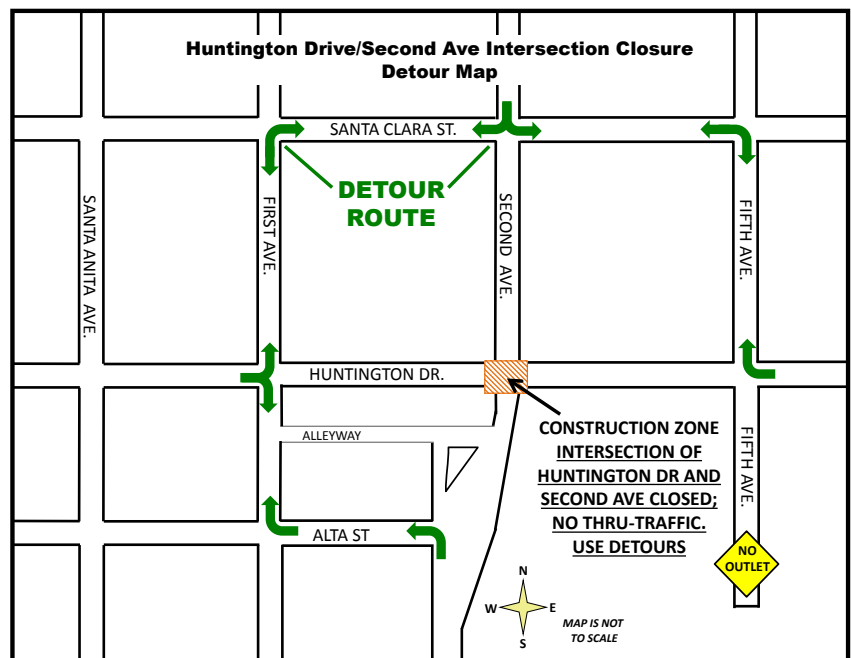
